I, Bharat Sharma, Settlor and National President of Environment Forest and Climate Change Commission (Autonomous Commission), having its office at Prakarti Sadan, 23, B-Block, Sector-12, Dwarka, New Delhi - 110078, do hereby issue this public notice for general information and caution.

It has come to my knowledge that certain persons, previously associated with the Commission as members or office bearers, are acting in contravention of the aims and objectives of the organization and are attempting to misuse the name, designation, identity, and platform of the Commission for unauthorized purposes. It is also brought to notice that any website, social media account, or digital platform operating in the name of the Commission without official authorization shall be treated as unauthorized and illegal.

**In order to safeguard the integrity, credibility, and lawful functioning of the Commission, it is hereby declared that all existing memberships, appointments, designations, authorities, and prior orders issued to any member stand terminated and cancelled with immediate effect.**

It is further clarified that all appointment letters, authorizations, identity cards, visiting cards, and any official orders issued prior to the date of this notice shall be treated as **NULL AND VOID with immediate effect.**

**The Environment Forest and Climate Change Commission is a duly registered trust under the applicable provisions of the Trust Act and is working for environmental protection, conservation, and public welfare in alignment with the spirit of Article 48A and Article 51A(g) of the Constitution of India. It is further clarified that the Commission is an independent registered trust and not a Government body, nor affiliated with any Central or State Government authority.**

The Commission shall issue fresh appointments/memberships only through its newly designated official platform/website, as per revised norms and verification procedures.

All concerned persons are hereby directed to deposit their Identity Cards, Visiting Cards, Appointment Letters, and all official stationery/material of the Commission within 07 (seven) days from the date of this notice at the official office or through authorized mode.

In case of non-compliance within the stipulated period, the concerned individual shall be personally responsible for any consequences arising therefrom, and the Commission shall be at liberty to initiate appropriate legal action, including civil and criminal proceedings including provisions under relevant sections of **Bharatiya Nyaya Sanhita, 2023 relating to cheating, impersonation, criminal breach of trust, and fraud.**

The general public, authorities, and all stakeholders are hereby cautioned that no person is authorized to represent or act on behalf of the Commission unless duly appointed afresh in writing. Any dealing with unauthorized persons shall be at their own risk and responsibility. The Commission shall not be liable for any acts done by such individuals. **Any person continuing to represent the Commission after issuance of this notice shall be deemed to be committing offences including fraud, impersonation, and cheating, and shall be liable for strict legal action.**

The Commission reserves the right to lodge complaints with Police Authorities, Cyber Crime Cell, and other competent agencies against any individual or entity found misusing its name, identity, or platform.

This notice shall be treated as final and binding communication to all concerned persons.

This notice is issued in public interest to maintain transparency and prevent misuse.
